Marketing Affiliate / Introducing Broker Agreement

PRIVATE & CONFIDENTIAL

1. Parties

This Marketing Affiliate / Introducing Broker Agreement (“Agreement”) is entered into between:

1. UEXO Global Ltd (“UEXO” or the “Company”), incorporated in Mauritius under registration number 179291 and authorised and regulated by the Financial Services Commission (“FSC”) of Mauritius, with its registered office at 12th Floor, Hennessy Court, Pope Hennessy Street, Port Louis, Mauritius; and
2. The natural or legal person approved by UEXO as a Marketing Affiliate / Introducing Broker (the “Affiliate” or “IB”).

2. Appointment & Scope

UEXO appoints the Affiliate on a non-exclusive and revocable basis to introduce prospective clients to trade foreign exchange, metals, CFDs and other derivatives (“Products”) offered by UEXO.

The Affiliate acts strictly as an independent contractor. Nothing herein creates an agency, partnership, joint venture or employment relationship. The Affiliate has no authority to bind UEXO.

3. Payment Schedule

Fees accrue only on genuine, closed and funded trading activity of approved clients. UEXO reserves the right to adjust, recalculate, withhold, set-off, suspend or claw back fees where trading is abusive, fraudulent, error-based, rebate-driven, subject to chargeback, or required by law.

Commission Cap: Under no circumstances shall the total rebate and/or commission payable to the Affiliate exceed forty percent (40%) of the net revenue generated from each introduced client unless expressly agreed in writing by UEXO.

4. Affiliate Representations&Obligations

The Affiliate represents and warrants that it shall conduct its activities in good faith, professionally and in compliance with all applicable laws and FSC requirements.

The Affiliate shall not provide investment advice, discretionary trading services, or guarantee returns. The Affiliate shall not handle client funds.

The Affiliate shall clearly disclose to each client that it receives compensation from UEXO.

5. Regulatory&AML Compliance

The Affiliate confirms that it is appropriately authorised where required or not required to be regulated in its jurisdiction. The Affiliate shall comply with AML/CFT obligations and notify UEXO of any suspicious activity or regulatory inquiry.

6. Intellectual Property

The Affiliate shall not use UEXO's name, logo or intellectual property without prior written consent. All intellectual property remains the exclusive property of UEXO.

7. Confidentiality

All confidential information exchanged shall remain confidential and shall not be disclosed without prior written consent except where required by law. This obligation survives termination.

8. Indemnity

The Affiliate shall indemnify and hold harmless UEXO from any loss, liability, damage or expense arising from breach, misrepresentation, negligence or non-compliance.

9. Limitation of Liability

UEXO shall not be liable for indirect, incidental or consequential damages, including trading losses. Nothing excludes liability for fraud or wilful misconduct.

10. Term&Termination

This Agreement remains in force for one (1) year and renews automatically unless terminated by either party with seven (7) days' written notice.

UEXO may terminate immediately for breach, fraud, insolvency, regulatory concern or reputational risk. No further fees shall accrue after termination.

11. Governing Law&Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of Mauritius. The courts of Mauritius shall have exclusive jurisdiction.

12. Miscellaneous

If any provision is held invalid, the remaining provisions remain in force. This Agreement constitutes the entire agreement and may only be amended in writing signed by both parties.
