Terms and Conditions

Program Period: 17th August 2026, 00:00 server time – 18th September 2026, 23:59 server time

Entity Details: Program is offered by UEXO Global Ltd (Mauritius FSC, license # GB21026300)

Eligible Countries: China

Register for the Program, Deposit USD 500 and start trading to earn up to USD 8,888 as cashback on your trades.

1. Eligibility

- This Program is open to all clients (existing & new) who registered for the Promotion via the Landing Page residing in applicable countries and who hold a Live trading account with UEXO Global Ltd. (UEXO)
- Only Clients whose account has been fully KYC verified and make a minimum deposit of USD 500 are eligible to participate.
- Only Standard Accounts are eligible. Pro, ECN, MAM/PAMM accounts are excluded from this promotion.
- Each Client may register only one account for the Program.
- This promotion cannot be combined with any other promotion or bonus offer running concurrently.

2. Registration

- The Client must actively register for this Promotion via the Landing Page.
- Trades executed prior to the Client's successful registration for this Program will not be counted towards the Qualifying Volume.
- Registration is specific to a single nominated trading account. Activity on any other account held by the Client will not be counted.

3. Qualifying Volume

- Qualifying Volume is measured in standard lots and is calculated on a round-turn basis: a position is counted once, at the point at which it is closed. Only positions both opened and closed within the Program Period and after successful registration will be counted.
- Eligible Products are: FX Majors, FX Minors, Gold (XAU), Silver (XAG) and Oil.
- Positions held for less than three (3) minutes between execution of the opening order and execution of the closing order will be excluded from Qualifying Volume.

5. Calculation and Crediting of Rewards

- UEXO will calculate each Client's Qualifying Deposit and Qualifying Volume following the close of the Program Period.
- The Cash Reward will be credited to the Client's Wallet within five (5) business days of the end of the Program Period.
- The Cash Reward will be credited as real, withdrawable funds.

6. Withdrawals

- Clients may not make any withdrawal/transfer funds out from the Eligible Account between the date of registration and the date on which the Cash Reward is credited. Any withdrawal request submitted during this period will result in forfeiture of the Cash Reward.

- Where prohibited conduct is suspected, UEXO may disqualify the Client from the Program and reverse any Cashback Reward already credited.
- Where UEXO determines that multiple accounts are held or controlled by the same Client, we reserve the right to treat those accounts as a single participant or to disqualify all such accounts.

- UEXO's determination as to whether conduct falls within this Section is made at its sole and absolute discretion and is final.
